
Digital Citizenship Responsible Use Agreement Year 1-3

This is achieved by following the rules laid out in this Responsible Use Agreement and in accordance with relevant laws like the Harmful Digital Communications Act and the Safe Schools Policy. The school has infrastructure in place to filter and monitor what happens online.

If someone cannot agree to act responsibly, or the things they do mean that other people are being harmed or disrespected, then we might stop them from using the internet and other technologies at school.
